## We stand with women refugees

In 2025, the number of forcibly displaced people fleeing persecution, conflict and violence rose to 123 million, 38 million of whom were classified as refugees. That's 1 in 67 human beings worldwide. 49% are women and girls, subject to additional risks of gender-related levels of physical, psychological and sexual violence. In the two-year civil war in Sudan – considered the worst current humanitarian crisis – displaced women and girls have been subjected to live streamed rape, designed to destroy them, their families and their communities.

2025 simultaneously saw an unprecedented decline in international aid for dealing with the root causes of displacement and migration, including in the UK, where budgets have been slashed and over 20% of development aid intended for protection, education and healthcare in vulnerable communities around the world has been spent domestically on housing asylum seekers due to the backlog in processing claims.

International protection is now being further undermined by calls for long-established human rights laws to be diluted or even scrapped, with the UK government amongst those seeking to “modernise” the European Convention on Human Rights (ECHR) by diluting Articles 3 and 8, offering vital protection against torture and family separation. If governments renege on their legal and moral obligations, we will see an unacceptable rise in lawlessness and impunity, as evidenced by illegal attacks on sovereign states in Europe, the Middle East and, most recently, Venezuela.

Against this backdrop, refugee women are risking their lives to save their families in their struggle for survival. They are a powerful resource even in the most challenging circumstances, and the Women in Black stand with them and UK organisations that seek to help them rebuild their lives, such as:
